 The Intervenor / Applicant is filing the present Application before this Hon'ble Court seeking permission to intervene in the present proceedings as the Intervenor / Applicant is praying for suitable directions to be passed to the Golden

Forest (India) Limited Committee to take appropriate steps for identification, demarcation, and valuation of certain lands belonging to GFL situate at Lingojigudem / Thangadapally villages in Chountppal Mandal, Telangana, and for sale of the said Lands through public auction or any other mode of sale, as may be directed by this Hon ble Court in a time bound manner.

- 2. The Intervenor/Applicant is a listed Public Limited Company and is one of the leading manufacturers of generic Active Pharmaceutical Ingredients (APIs). Intermediates and Registered starting materials. The Intervenor/Applicant was established in the year 1994, and exports to more than 95 countries.
- 3. The Intervenor/Applicant operates a manufacturing facility at Choutuppal Mandal, Lingojigudem revenue village, Yadadri Bhuvanagiri district inter alia for manufacturing bulk drugs and R&D products etc. The Intervenor/Applicant's manufacturing facilities have the Quality, Environment, Health and Safety management system certifications from ISO 9001, ISO 14001, ISO 14064, ISO 18001, and ISO 22000.
- 4. The Intervenor/Applicant submits that vast parcels of lands in all admeasuring about 1091.331 Acre belonging to M/s. Golden Forest (India) Limited ("GFIL") is situate in Choutuppal Mandal, District Nalgonda (now known as Yadadri Bhuvanagiri District of Telangana state). Of this total extent of 1091.331 Acre, the Intervenor / Applicant is interested in purchasing lands admeasuring about Acre 346.21 cents ("said Lands") belonging to GFIL which are
