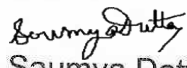

**REPLY BY THE COMMITTEE – GFIL (APPOINTED BY
HON'BLE SUPREME COURT)**

MOST RESPECTFULLY SHEWETH:

1. That the applicants have a claim over the lands of Golden Forest India Limited situated in the village Lingo jigodem Mandal Chhoutupal, District Yadadri Bhuvnagiri (Telangana) and seeking direction to exclude their land to the extent of 3 Acres 16 Guntas out of 23.23 Acres comprised in survey no. 234 from the lands of Golden Forest India Limited to be auctioned by Income Tax Department under the orders of this Hon'ble Court.
2. That the applicants applied to the Tehsildar concerned for entry of their names being missing in the revenue record vide application ID no. 2600027956. The application was rejected by

the Tehsildar Chhoutupal Mandal specifying in detail the ownership of Golden Forest India Limited over the entire extent of 23.23 acres comprised in survey no. 234 on the basis of various sale deeds in its favour. Copy of 'Check memo for grievance for Pass book data correction' has been filed as Annexure A/3 of the application.

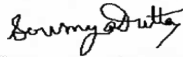
3. That the District Collector Yadadri Bhuvnagiri in his compliance affidavit filed on behalf of the State of Telangana in compliance to order dated 20.1.2026, has also mentioned at page no. 39 the entire 23.23 acres comprised in survey no. 234 to be of Golden Forest India Limited. That is no portion of the land under this survey number was mentioned to be under the possession of any other person.
4. That this Hon'ble Court vide order dated 15.10.2008 passed in TC.(C). 2 of 2004 directed that third party claims over the properties of Golden forest group shall be considered by the Committee-GFIL. More recently this Hon'ble Court vide order dated 15.5.2025 at para 4 (xv) directed as under:

"(xv) Third party disputes shall be adjudicated by the GFIL Committee, i.e., "Disputes regarding possession, ownership, title of properties which were purchased by GFIL group of companies and which are in the custody of the Committee shall be adjudicated by the GFIL-Committee"."

The claim in the present application is a third party dispute and therefore under the above direction of this Hon'ble Court, the dispute shall be adjudicated by the Committee-GFIL appointed by this Hon'ble Court.

5. Therefore in view of the directions of this Hon'ble Court passed in order dated 15.5.2025, the applicants may please be directed to file their claim before the Committee.

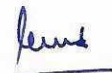

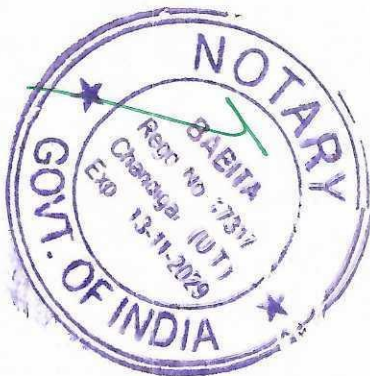
